
### **CORONAVIRUS NEWS**

#### What is coronavirus disease 2019 (COVID-19)?

Coronavirus disease 2019 (COVID-19) is a respiratory illness that can spread from person to person. The virus that causes COVID-19 is a novel coronavirus that was first identified during an investigation into an outbreak in Wuhan, China.

### How does COVID-19 spread?

The virus that causes COVID-19 probably emerged from an animal source, but is now spreading from person to person. The virus is thought to spread mainly between people who are in close contact with one another (within about 6 feet) through respiratory droplets produced when an infected person coughs or sneezes. It also may be possible that a person can get COVID-19 by touching a surface or object that has the virus on it



and then touching their own mouth, nose, or possibly their eyes, but this is not thought to be the main way the virus spreads. ### IOWA RESOURCES FOR BUSINESSES

The Iowa Economic Development Authority has rolled out programs to help businesses during the Coronavirus Crisis. These are in addition to federal programs through the CARES act passed by Congress and the Small Business Administration Loan Program recently announced. The Paycheck Protection Program is a loan designed to provide a direct incentive for small businesses to keep their workers on the payroll. SBA will forgive loans if all employees are kept on the payroll for eight weeks and the money is used for payroll, rent, mortgage interest, or utilities. ### Downtown Assessments Bring Outside Perspectives

The cities of Anamosa and Monticello recently completed Downtown Assessments through the Iowa Downtown Resource Center. The Downtown Resource Center helps communities learn more about the importance of downtown development and specifically how communities can use specific tools to make downtowns more viable. The Assessments are designed to help identify the downtown's strengths and weaknesses while offering community-based and incremental solutions to keep the downtown strong.

"The downtown is the heart of a community," says Derek Lumsden, Executive Director of Jones County Economic Development. "If the downtown isn't strong, it's hard for the rest of the community to develop the way it should. It's harder to attract residents, jobs, housing, etc. These assessments were an ideal way to involve the community in removing the blinders from their eyes to the way outsiders see the communities."

Each community received a written assessment report, highlighting different areas that could be focused on by small groups working together. The assessments have both short-term and long-term goals for both communities to achieve. Both communities will also receive two free registrations to the Iowa Downtown Conference in Iowa City this summer to learn more about downtowns and learn best practices from other communities across the state.

### Legislative Forums Offer Chance to Interact with Legislators


Jones County Economic Development would like to thank our legislators for attending two of our legislative forums this winter.


