

JONES COUNTY ECONOMIC DEVELOPMENT EQUALS A GREAT RETURN ON YOUR INVESTMENT!

With the start of the new year, many people and communities are looking at how they budget and how to spend their money in ways that maximize the output. Jones County Economic Development (JCED) is a public-private partnership dedicated to strengthening the economic base in Jones County by assisting existing businesses, attracting new investments and jobs, and fostering a business climate favorable for economic growth. And over the last eight years, JCED has consistently shown an ability to maximize returns on investments for the businesses and communities of Jones County.

Over the last eight years, Jones County Economic Development has either directly secured or was vital in helping secure just under \$15 million in grants for projects throughout Jones County. These grant

COMMUNITY CAREER TOURS SHOWCASE A FUTURE IN HEALTHCARE

Every year, Jones County graduates dozens of talented students from their respective school districts. These graduates are ready to pursue their next chapter in life, be that to going to college or going straight to work in some capacity. While going to college has an outright path that gets a lot of guidance, helping those students that want to go straight to work can seem limited at times.

Each year, Jones County Economic Development works with high school students to explore potential career paths that exist inside Jones County businesses. JCED partners with area high schools to take their 9th grade classes out on Community Career Tours each year. These tours focus on a different business sector each year (manufacturing, healthcare, small business, agriculture, etc.) and the students visit two businesses representing each field. Additionally, the tours move around the different communities in Jones County, showcasing all of the great businesses as well as the ample opportunities to work locally.



This year, students from Anamosa, Cascade, and Midland high schools came to Anamosa to explore some different jobs in the healthcare field. Students were able to visit the Jones Regional Medical Center to learn about physical therapy, the ambulance/ EMT department, and more.

Additionally, those students also visited Pinicon Senior Living to see what services and unique job possibilities exist in the care center world. From food service and events coordinator to memory care health and more, students were able to see the types of jobs needed and the variety of residents that might be in such a facility. Students also learned about the rules on



working in such facilities as well as the criteria to volunteer at local businesses in the healthcare world.

Jones County Economic Development is proud to work with area businesses to help showcase the great businesses, talent, and opportunity in our region. JCED is also proud to work with Kirkwood Community College to help students gain an understanding of the local work possibilities before they sign up for career academies in their junior and senior years of high school.

In Anamosa, JCED has overseen two successful Community Development Block Grant projects for 20 façade restorations with another 11 facades being rehabilitated in 2026 and 2027. Those projects have not only increased the historic integrity of the downtown and made it more attractive to residents and visitors alike, but so too has it helped decrease the number of vacancies in downtown buildings! These three projects alone will have over \$1.8 million invested in Anamosa's downtown. While some of the transformations may seem minor, others

have completely revolutionized some of the downtown buildings and made them even more vibrant than before! And the final project is expected to commence this spring, so stay tuned to see even more revitalization happening in the downtown!

Additionally, JCED has worked with the City of Anamosa on three projects aimed at getting buildings back into service. The first was an Emergency Catalyst Grant for the Arts Court building in downtown Anamosa. After a fire gutted the building, this grant helped bring it back to life with the gallery refurbished on the first floor and two upper story housing units on the second floor. JCED also has worked with ECIA out of Dubuque and the Environmental Protection Agency (EPA) to get money to do assessment work on the old Collins building and the old Anamosa hospital. These grants helped test for different hazards such as asbestos and lead paint while also allowing JCED to host community meetings to get input from residents on what should happen with those buildings to fill community needs.

In Monticello, JCED has worked to help renovate a dilapidated building, formerly known as Compadres, into a usable and beautiful space now known as Market at the Tap. This building was renovated with \$150,000 in grant funding secured by JCED, helping kick off some other great projects in the community. JCED was instrumental in helping bring down the old



Energy building in Monticello and encouraging Hy-Vee Dollar Fresh to town. JCED was also helpful in working with the City on the old Dollar General Building restoration as well as the Fountain Park project over by the Aquatic Center. Finally, JCED was directly responsible for bringing the Main Street program and approach to Monticello, allowing them access to free services for businesses in the downtown district while helping it retain its historic charm.

Jones County Economic Development has also helped numerous businesses with projects over the last eight years. In the last few years, JCED has helped secure multiple \$75,000 grants through the State of lowa for businesses to expand their technology needs and grow their businesses. These grants have allowed businesses to try and develop new ways of developing workforce and grow at a faster rate in a more technological world. Between these direct grants and indirect ones that assisted with childcare and housing needs, JCED is always ready to help serve the Jones County business community.
